

## DEALING WITH THE DARK SIDE OF COUNSELLING AND PSYCHOTHERAPY

Dr Lynne Gabriel will be presenting her ideas of Supervisors being 'Boundary Riders and Sentinels' and Roger will be looking at setting and maintaining Boundaries and avoiding complaints.

**Dr Lynne Gabriel** is Reader in Counselling and Relational Ethics, as well as Head of Programme for Postgraduate/Past Experience Counselling studies at York St. John University. She also leads the MA Counselling Studies programme and supervises PhD counselling students. Lynne is a Fellow of BACP and has been an active member of BACP since 1998, particularly via committee membership and Chair roles. She was elected Chair of BACP in 2009. She has been active in the field of practice ethics for some years publishing several papers and articles on the subject, as well as presenting her papers at national and international conferences. Her research interests include qualitative research methods, relational and practice ethics, research and researcher ethics, client perspectives on therapy and therapists, supervision and spirituality. She is the author of *Speaking the Unspeakable: the Ethics of Dual Relationships in Counselling and Psychotherapy* and her most recent book, co-edited with Roger Casemore is *Relational Ethics in Practice: Narratives from Counselling and Psychotherapy*.



**Roger Casemore** is currently Senior Teaching Fellow and Director of Counselling and Psychotherapy Courses at the University of Warwick. He has practiced privately as a therapist for 40 years and as a supervisor and trainer of counsellors, for the past 30 years. He is a Chartered Fellow of the Chartered Institute of Personnel and Development and a Fellow of the British Association for Counselling and Psychotherapy. He is a past Chair of the British Association for Counselling, was President of Counselling in Education for 15 years and Chair of the BACP Complaints Committee for two years. For a number of years he was a Trustee of BACP, Chair of the Audit Committee and a member of the Professional Conduct Committee and the Supervision Forum.



Roger qualified originally as an accountant in local government finance, before moving on to read Psychology and then to train as a Person - centred therapist and group worker. He began his career in the education service as a detached youth worker, mainly with young drug abusers in Central London. He then worked in a variety of youth and community settings in the London area before becoming a Further Education Advisor in Derbyshire. He moved from there to become Senior Education Officer responsible for Community Education in Coventry and then moved to a government QUANGO, the National Youth Bureau where he was Deputy Director and then Director. After a short period as Assistant Director of Education in North Tyneside, he finally moved to the Royal Borough of Kensington and Chelsea, where he became Director of Continuing Education, Community Liaison, Economic Development, Training and Employment Services.

Having completed 31 years local government service, Roger took early retirement in 1994. Since then he has been successfully running his own company, KASMOR Consultancy, working with private, public and voluntary sector clients across the UK, as a consultant in the Psychology of Organisations specialising in culture change, conflict management and conciliation in organisations, project management and project development in inner city areas. He provides a special service of confidential consultancy for chief executives and other senior managers.

Roger is the author of *Surviving Complaints against Counsellors and Psychotherapists: Towards Understanding and Healing*, as well as *Person-Centred Counselling in a Nutshell*, one of the Counselling in a Nutshell Series edited by Windy Dryden.
